1. Introduction

COORDINARE – South Eastern NSW Primary Health Network (South Eastern NSW PHN) is one of 31 Primary Health Networks (PHNs) established throughout Australia with the key objectives of improving the efficiency and effectiveness of health services for patients, particularly those at risk of poor health outcomes, and improving coordination of care to ensure patients receive the right care in the right place at the right time. Our focus is on local health needs as well as national health priorities and funded programs, particularly in the areas of chronic disease, mental health, drug and alcohol, Aboriginal health and end of life care.

2. Pitch Night background

Pitch Night – 2019 is a new initiative by South Eastern NSW PHN where local community based organisations, including not-for-profits, can pitch their innovative ideas for initiatives that address health needs of their communities in an effort to secure one-off funding. South Eastern NSW PHN is calling for submissions for our first *Pitch Night*.

3. What is a Pitch Night?

Pitch Night is an exciting opportunity for local community-based organisations, including not-for-profits, from the Wollongong and Shellharbour region, to 'pitch' their innovative ideas to address the health needs of their local communities in an effort to secure funding for their idea.

The benefit for those pitching is to gain exposure of their ideas, community support and funding to move their initiative forward.

The aim is to provide one-off grant funding which supports innovative initiatives that meet the needs of the community and potentially act as a catalyst for implementation in other communities.

On the night, presenters will pitch for six-minutes and respond to questions from the audience. The presenters then leave the room before the guests pledge funding for each organisation. When the pledging is finished, the presenters are invited to return and the final tallies for each project are announced. You can view highlights from similar events held by clicking this link:

4. What is the process of selection?

Up to six initiatives will be shortlisted by a selection panel. The shortlisted applicants will be invited to participate in a ten minute telephone interview to be held on 21 May 2019. From these interviews, three final initiatives will be selected for presentation on *Pitch Night*.

The three selected applicants will be required to participate in a mandatory half-day pitch coaching workshop, to develop and refine their 'pitch'. This workshop will be held on 5 June 2019 in Wollongong. Fully prepared and ready to 'pitch', the three selected applicants will deliver their pitch to the audience on the evening of 26 June 2019 in Wollongong.

5. What is the focus of the South Eastern NSW PHN Pitch Night?

South Eastern NSW PHN is seeking to fund innovative initiatives that:

'Improve health and wellbeing in Aboriginal, refugee and/or youth at risk groups within the Wollongong and Shellharbour regions.'

Grant submissions must:

- have a clear alignment to the purpose of achieving and maintaining good health and wellbeing through increased physical activity and/or improved nutrition:
 - o working with the community to be more physically active
 - o food as a pathway to health
- o be based within the Wollongong and / or Shellharbour region
- o focus on one or more of the identified groups (Aboriginal, refugee and/or youth at risk)
- o demonstrate how you will co-design the initiative with the relevant community

A total funding pool of \$160,000 (ex GST) is available to be allocated across three initiatives.

Submissions should be based on potential grant funding of \$40,000 (ex GST) per initiative and an indicative budget based on that amount needs to be included in the application. The three selected initiatives will receive a guaranteed once only funding amount of \$40,000 (ex GST). All three applicants will have the opportunity to increase this amount by influencing the audience with their 'pitch' on *Pitch Night*.







6. Eligibility and reporting

Organisations that apply must be community-based (including not-for-profits) operating locally, and working with either the Aboriginal community, refugee community and/or youth at risk.

Submissions from a consortia of organisations will be accepted.

Organisations must operate in the Wollongong or Shellharbour regions and have a combined annual income of less than \$5 million.

Applicants must be available for the ten-minute telephone interview, attend the Pitch coaching workshop and the Pitch Night as outlined in the 'indicative timeline' table below. There will be no alternative times available.

Applicants must nominate an 'advocate' who will support their application and attend Pitch Night, see section 12 below.

Successful applicants will be required to be in a position to sign a contract with COORDINARE immediately after the event and attend a contracting meeting with COORDINARE in Wollongong on 27 June 2019. A reporting template will be provided to successful applicants with a six month report and a final report outlining the reach and impact of the initiative required.

7. What support will I receive on my pitch?

Prior to the *Pitch Night* event, the three finalists will be required to attend a half-day coaching workshop to develop their pitches. COORDINARE is working with The Funding Network, a not-for-profit organisation who are expert in the area of developing people to tell their stories. This session will be held on Wednesday 5 June 2019. It is expected that at completion of this workshop each participant will have a first draft of their pitch. Participants are encouraged to rehearse between the pitch workshop and *Pitch Night*.

An information session/Industry briefing webinar will be held on 16 April 2019. This session will focus on the grant guidelines, process and *Pitch Night* concept. Session details are as follows:

10. Developing and submitting your application

Lodge your application via https://www.tenderlink.com/COORDINARE/. You will need to register on the site before you can access the submission/evaluation portal. Registration is free. You will receive a time and date stamped confirmation upon successful submission.

Please ensure you read each assessment criterion carefully and answer each component and section of the submission/evaluation form by considering all information provided.

Submissions from groups planning to work together with a specific focus on identified priority areas and populations are encouraged to apply.

11. Applicant questions

All questions in relation to this grant process and *Pitch Night* can be submitted anonymously via the online forum following registration on Tenderlink at https://www.tenderlink.com/COORDINARE/ up until 1 May 2019.

Please note: any questions, answers and points of clarification will be shared with all other providers participating in the application process. Any identifying information about the organisation submitting the question will be removed. All applicants are strongly encouraged to attend the industry briefing webinar on the 16 April 2019.

12. Pitch Night advocate

Applicants must nominate an 'advocate'. An 'advocate' is an independent supporter of the applicant. It is someone who is neither a paid staff member/board member or family member, but someone who has first-hand knowledge of the organisation's work.

On *Pitch Night*, your advocate must attend and will be invited to briefly speak to the audience to attest to the work of the finalist.

If your organisation is selected as a finalist, the advocate plays an important supporting role at the *Pitch Night* event.
